On April 14, 2014, at approximately 10:15 p.m., Detective Troy BISGARD, 98009 of the Homicide Unit was contacted by Sergeant James KUKURIS also of the Homicide Unit and notified of a Homicide at 2112 S. St. Paul St. Detective BISGARD was informed that members of the Denver Police Department were sent to the address at approximately 9:32 p.m., on a domestic disturbance call. Upon Officers' arrival in the residence they located a male, later identified as Richard KIRK, dob: 05/15/1966, and a female lying on the floor with an apparent gunshot wound to the head. The victim was pronounced deceased at the scene at 9:58 p.m., by Dr. MCVANEY through Denver Health Medical Center Paramedics. Detective BISGARD was then assigned the investigation and asked to respond to Denver Police Headquarters.

Upon Detective BISGARD's arrival he listened to the 911 call from the incident. The caller identified herself as and said that her husband, Richard KIRK, dob: 05/15/1966, was talking about the end of the world and he wanted her to shoot him. She said that there was a gun in the residence but that it was in a safe. She said that her husband was hallucinating and he was scaring their three small children. She then said that her husband retrieved the gun from the safe and she began to scream. Detective BISGARD then heard an apparent gunshot and the victim was not heard on the call again.

Detective BISGARD then spoke with Officer Eric RIEDMULLER, 01022. Officer RIEDMULLER was one of the first Officers on scene and assisted in taking Richard KIRK into custody. Officers RIEDMULLER placed Mr. KIRK in the backseat of his patrol car. At one point Mr. KIRK told Officer RIEDMULLER without questioning that he killed his wife.
