Natural causes of deaths include any of the following: Any Injury, asthma, cancer, cardiovascular, congenital anomaly, HIV/AIDS, influenza, low birth weight, malnutrition/dehydration, neurological/seizure disorder, pneumonia, prematurity, SIDS, other infection, other perinatal condition, other medical condition, and undetermined medical cause.

Accidental causes of death include any of the following: Any medical cause, motor vehicle, fire, burn, or electrocution, drowning, asphyxia, weapon, animal bite or attack, fall or crush, poisoning, overdose or acute intoxication, exposure, other Injury, and undetermined injury.

Suicide causes of death include suicide by any of the following: Any medical cause, motor vehicle, fire, burn, or electrocution, drowning, asphyxia, weapon, animal bite or attack, fall or crush, poisoning, overdose or acute intoxication, exposure, other Injury, and undetermined injury.

Death by homicide may include the following: Any medical cause, motor vehicle, fire, burn, or electrocution, drowning, asphyxia, weapon, animal bite or attack, fall or crush, poisoning, overdose or acute intoxication, exposure, other Injury, and undetermined injury
