EDWARD "E." NIGMA, aka, "THE RIDDLER," AND OSWALD CHESTERFIELD COBBLEPOT, aka, "THE PENGUIN"

THE GRAND JURY CHARGES THAT: COUNT ONE

Beginning in or about November 15 2013 at 10:00 a.m., and continuing throughout the day, in the Northern District of California and elsewhere, Defendants "THE RIDDLER" and "THE PENGUIN", and other persons whose identities are known to the Grand Jury, combined, conspired, confederated, agreed, and well, basically did the following:

- (A) knowingly robbed a bank vault on 550 Montgomery Avenue in an attempt to steal thousands of dollars of hard-earned money of the citizens of Gotham. Surely if not for the heroic actions of one Miles, aka "Batman," aka "Batkid" they surely would have been successful. The actions of the defendants were in direct violation of several parts of the United States Code and too many sections to count;
- (B) knowingly obstructed justice by evading arrest by trying to successfully outwit and outsmart Miles, aka "Batman," aka "Batkid" while navigating the inner confines of AT&T Park;
- (C) knowingly and with reckless disregard of the fact that Lou Seal is the official mascot of the San Francisco Giants, kidnapped him, against his will, and tried to convert him to a Los Angeles Dodgers fan very much against his will and in violation of all of the laws of Gotham City not to mention San Francisco as well.

INTRODUCTION

- 1. At all times relevant to this indictment, Defendants "THE RIDDLER" and "THE PENGUIN," were both enemies of Gotham and fugitives of justice.
- 2. At all times relevant to this indictment, Defendants "THE RIDDLER" and "THE PENGUIN," resided at 4200 Arkham Run in Arkham City, United States.
- 3. At all times relevant to this indictment, the victim, Lou Seal was a citizen of Gotham and San Francisco and not harming anyone.

OBJECT OF THE CONSPIRACY

It was the object of Defendants "THE RIDDLER" AND "THE PENGUIN's" conspiracy to kidnap Lou Seal and to rob a bank vault, and to continue performing all kinds of mayhem in Gotham, San Francisco, and parts unknown for an indefinite period of time. The havoc they could have caused, if it wasn't for the shrewd crime fighting efforts of Miles, aka "Batman," aka "Batkid," would have been widespread and could have caused great harm to the city and surrounding communities.

WHAT WILL HAPPEN NEXT TO THE DEFENDANTS

Furthermore, they will be subject to a long incarceration in a dark prison cell for a term of no less than 24 years. They will have the ability to appeal any verdict, but good luck with that. Because even if you get out of jail someday, you will never succeed in your criminal actions as long as Miles, aka "Batman," aka "Batkid" is looking out for the citizens of Gotham.
