



# **Fact Sheet: ESC Demolition/Construction**

# **General Information:**

- The Kings have City approval to work from 6 a.m. to 11 p.m. Monday through Saturday.
- There are three (to-be-announced) phases where crews will do night work between 8 p.m. and 6 a.m.
- Demolition will start in late July the public will be notified of the start date 24-48 hours prior.

# Project schedule:

Summer 2014 Truck deliveries and barrier/fence set up. Street re-striping. On-site

abatement work and utilities shut-off. Includes night work. Demolition and removal of

existing buildings, including use of excavators, hoe rams and forklifts.

Summer/Fall 2014 Mass excavation of site.

Fall 2014/Winter 2015 Drilled displacement piles and foundation construction.

Winter/Summer 2015 Concrete slab pours (concrete truck deliveries planned between 8 p.m. and 6 a.m. to

avoid commute traffic). Steel structure erection, welding and installation (includes

installing vertical steel, but not roof steel).

Summer/Fall 2015 Building façade of precast concrete, metal and glass built. Roof constructed.

Fall 2015-2016 Interior assembly.

Fall 2016 ESC complete and open to the public.

# **Demolition Activity/Background:**

## **BARRICADES**

- 7th street side between University of San Francisco and 24 Hour Fitness, which will include a viewing window.
- 5th street side between the east and west plaza (by Macy's and the River City Brewery), which will include a viewing window.
- Process: chain link fencing, sound barriers and wooden fencing with logos and wayfinding signs.

### **GARAGES/PARKING**

- Of the 3,700 total parking spaces in the three City-owned parking garages, 1,780 will remain open in the Downtown Plaza West (3rd and L Street) and Central (5th and J Street) garages.
  - o In addition, 300 parking spots will remain available in a portion of the Downtown Plaza East (7th and J Street) garage under 24-Hour Fitness and the 660 J Street office building.
- Once demolition officially begins, the Downtown Plaza East Garage entrances at 6th and L Street and 6th and J Street will close, with only the entrance at 7th and K Street open to daily parkers at Downtown Plaza East.
  - The Plaza East Garage stopped providing parking to monthly customers as of June 21.
- All other entrances and exit locations at Downtown Plaza West will remain open.

#### **RECYCLED/SALVAGED MATERIALS**

NOTE: All materials will be sent to recycling centers in Northern California or the Central Valley.

## STREET RE-STRIPING

- Construction will require temporary nighttime street closures from 7 p.m. to 6 a.m., and each street is expected to take one to two nights to complete.
- Street signs (including a temporary signal and stop sign placed at 6th and L Street) will be in place a week prior.

# L Street:

- o Three lanes will remain as all lanes shift to the left.
- Bus stops on L Street (between 5th and 7th Street) will be relocated to Capitol Mall between 7th and 8th Street.

# • J Street:

- Bus stops won't be impacted.
- A temporary crosswalk will be installed at 6th and J Street to accommodate pedestrian traffic.
   Upon completion of the project, the temporary crosswalk will be removed and the existing crosswalk will be reopened.
- J Street's south sidewalk (between 5th and 6th Street) will be closed so pedestrians should the north sidewalk.

### • 5th Street:

- 5th Street's east sidewalk (between J and L Street) will be closed so pedestrians should use the
  west sidewalk.
- 5th Street will lose one northbound lane, but one northbound bike lane will remain open and a southbound bike lane will be added.
- Bridge will remain intact through demolition.

### • 7th Street:

- No changes.
- NOTE: The City of Sacramento is starting a sewer project at 7th and L Street in mid-late August 2014. This is separate from the ESC, and the City will provide the public regular updates.

NOTE: Demo area is between 5th, 7th, J and L Streets. Demo area DOES NOT include Macy's, the Marshall Hotel, Jade Apartments, 24-Hour Fitness, the 660 J office building, Scientology building and the University of San Francisco building on 7th Street.

NOTE: The construction team has City approval to work from 6 a.m. to 11 p.m., Monday through Saturday. That allows two eight-hour shifts per day to meet the September 2016 finish date. During three to-be-announced phases, night work will be done between 8 p.m. and 6 a.m.

NOTE: Per the environmental impact report (EIR), generators will be used on-site to minimize the noise. They'll include mufflers and dampers, which will be placed as far from residences and businesses as possible.
